

Thursday April 24, 2014

The Trustees of Lawrence Township met in regular session at 7:00PM. in the Charles E. Lundenberger Memorial Meeting Room. The meeting was called to order by Chairman Ritterbeck. All Trustees were present. The minutes of the last meeting were approved. The following bills were presented for approval.

The above bills were approved by the Board and checks were written. Motion by Ritterbeck and seconded by Haueter to relist the Dodge Sheriff's car on govdeals.com at a reserve of \$6,000. Roll call, Ritterbeck yes, Haueter yes, Ackerman yes. Motion by Ritterbeck and seconded by Ackerman to approve Resolution 14-14 to request the Ohio EPA to allocate \$7,500 from the River Park Community Benefit Fund and approve payment of \$7,500 to Earth & Wood for one annual time in 2014. This will reopen the compost collection site for 2014. Roll call Haueter abstain, Ritterbeck yes and Ackerman yes. Trustee Ritterbeck will ask Bolivar and Zoar for funds to help offset the cost. If we cannot come up with the funds I will no longer pursue keeping the composting open. Motion by Ritterbeck and seconded by Ackerman to purchase \$50 gift cards for Andy Mark, Scott Edwards, Aaron Salapack, Richard Harvey and David Besse of the Zoning Appeals Board and for Stan Koehlinger, John Walsh, Eric McGovern and Frank Bachman of the Zoning Commission. Roll call Haueter yes, Ritterbeck yes and Ackerman yes. Tedd Finlayson asked if the Trustees were going to file an injunction against Tom Shetler, owner of Action Now, for constructing a building on Fort Laurens road. Trustees said no they were not. Even through not all the trustees were happy with the Zoning Board of Appeals decision they are prepared to live with it. Motion by Ackerman and seconded by to appoint George Downs Jr. to the zoning commission. Roll call Haueter yes, Ritterbeck yes and Ackerman yes. Motion by Haueter and seconded by Ritterbeck to go into executive session to discuss personnel. Trustees came out of executive session and a motion to hire Ron Weekley as a part time zoning inspector at \$16.00 per hour and to work some regular hours on Mondays and flex during the week for a total of 8 hours per week. Roll call Haueter yes, Ritterbeck yes and Ackerman yes. The Board then discussed Township affairs in general and a motion to adjourn was made and so ordered by the Chairman.
