Roll call Haueter yes, Ritterbeck yes and Ackerman yes. Motion by Ritterbeck and seconded by Haueter to appoint Ackerman chairman. Roll call Haueter yes, Ritterbeck yes and Ackerman yes. Chairman Ackerman proceeded to appoint Ritterbeck Health & Recreation Committee, and streets and roads. Ackerman then appointed Haueter regional planning alternate, Wellhead protection, safety committee and cemetery committee and Website.
