**Motion** by Ackerman and seconded by Haueter to approve Resolution 13-20 participating Salt Contract with ODOT. Roll call, Ritterbeck yes, Haueter yes, and Ackerman yes.

Ackerman indicated Reynolds was off work and will check with the county HR as to how they handle someone being off and also County Engineer. Ritterbeck reached out to Sheriff's Office regarding quote for new car and possible purchase of our old car. Trustees will advise cleaning lady to be more aware and sanitize areas. Trustees will reach out to Barb Limbacher when virus situation is under control and get the Times Reporter delivered to the township building. Trustees discussed summer help. Wayne Rex is willing to work 3 days a week. **Motion** by Ackerman and seconded by Ritterbeck to hire Raymond McClure at \$11 per hour (\$13 if has CDL). Roll call, Ritterbeck yes, Haueter yes, and Ackerman yes. **Motion** by Ackerman and seconded by Ritterbeck to hire Thomas Lundenberger at \$13 per hour (has CDL). Roll call, Ritterbeck yes, Haueter yes, and Ackerman yes. Trustees want to continue accepting applications. Trustees agreed to submit to Joint Solid Waste Management District a Grant for cement and new tires for the back hoe in the amount of \$22,212.64. This is a fully reimbursed grant; no township funds will be used if grant is approved. Trustee Ackerman discussed the impact of area businesses and the walking trail and suggested putting together a pamphlet having area businesses pay by advertising supporting Lawrence Township and businesses. The Board then discussed Township affairs in general and a motion to adjourn was made and so ordered by the Chairman.
