Ritterbeck advised Trustees that he has asked Martina Mann to research portable radar units, asked Zoning Inspector Weekley to research possibility of local businesses advertise at the new ballfields on St. Rt. 212, thanked Bull Compost for their support of 119 thirty-yard hoppers that were hauled from the compost which will remain open through the winter, and congratulated Mike Haueter and Don Ackerman re-elected Trustees.
