## **Regular Meeting**

# Held December 9, 2021

The Trustees of Lawrence Township met in regular session at 7:00PM. in the Charles E. Lundenberger Memorial Meeting Room. The meeting was called to order by Trustee Ackerman. Donald Ackerman and Matt Ritterbeck were present, Michael Haueter was absent. **Minutes Approved.** 

The above bills were approved by the Board and checks were written and fiscal officer gave trustees bank reconciliation for November, 2021.

### **RESOLUTION**

Ritterbeck made a **motion** to approve **Resolution 24-21** to set aside \$200,000 as temporary appropriations for fiscal year ending December 31, 2022, seconded by Ackerman. Ritterbeck:yes; Ackerman:yes. **Motion** passed.

#### MEETING

Ritterbeck is doing a feasibility study of the purchase of a Towable/Portable radar unit with flashing lights for the Township and checking if American Rescue Plan funds can be utilized. Ackerman reported Zoning Commission will have their monthly meeting January 10, 2022 and reorganize and asked for residents to try to keep vehicles off the roads, especially cul-de-sacs, to help when roads need snow plowed. Ritterbeck made a motion for a purchase order for \$8,200 for Tuscoat LLC for crack sealing, seconded by Ackerman. Ritterbeck:yes; Ackerman:yes. Motion passed. Ritterbeck made a **motion** to participate in the Tuscarawas County Asphalt program, seconded by Ackerman. Ritterbeck: yes; Ackerman: yes. Motion passed. McNutt asked trustees to review roads for recommendations for this program, still need part-time snow plow drivers with CDL license this winter, installed some rap in two bus turn arounds to help Tusky Valley Schools and tree trimming was complete and T. Rowley did a great job. Trustees received a letter from a resident on Welton regarding road issues, received additional complaints about Olde Hill Top development and will ask developer to install gravel and heard there was a good turnout for Christmas in Zoar. Mann presented trustees with park bench options and Ritterbeck made a motion to approve the purchase from The Park Catalog in the amount of \$2,104.97, seconded by Ackerman. Ritterbeck:yes; Ackerman: yes. Motion passed. Trustees then discussed Township affairs in general and a motion to adjourn was made and so ordered by Trustee Ackerman.
