Regular Meeting

June 30, 2022

The Trustees of Lawrence Township met in regular session at 7:00PM. in the Charles E. Lundenberger Memorial Meeting Room. The meeting was called to order by Chairman Ritterbeck. All Trustees were present.

Minutes from the June 9, 2022 regular meeting were approved.

PUBLIC SPEAKS

Bolivar Fire Chief Lynch advised Trustees that fireworks are now legal in Ohio with strict rules. Trustee Ackerman asked all residents to use caution when using fireworks and follow rules. Resident was concerned regarding the chip & seal on Ridge Road, road superintendent will look into alternative options.

RESOLUTIONS

Ackerman made a **motion** to approve **Resolution 28-22** allowing Lawrence Township Scenic Hills Road District to put a 2-mill replacement levy on the November ballot, seconded by Haueter. Ritterbeck:yes; Ackerman:yes; Haueter:yes. **Motion** passed. This levy is for 5 years commencing in 2023, first due in calendar year 2024. Ritterbeck made a **motion** to approve **Resolution 29-22** to realign permanent appropriations, seconded by Haueter. Ritterbeck:yes; Ackerman:yes; Haueter:yes. **Motion** passed.

MEETING

Ritterbeck presented Trustees with three options for replacing the sign by Sleep Inn. Ritterbeck made a **motion** to approve The Country Sign Company of Bolivar to replace the sign for \$8,450, seconded by Ackerman. Ritterbeck:yes; Ackerman:yes; Haueter:yes. **Motion** passed. Ritterbeck asked to adjust the memorial tree planting program to including any trees planted during the summer, it is the responsibility of the donor to water the tree. Ritterbeck made a **motion** to submit PUCO renewal applications for gas and electric aggregation, seconded by Haueter. Ritterbeck:yes; Ackerman:yes; Haueter:yes. **Motion** passed. Ackerman thanked McNutt for clearing the roads during the recent storms. McNutt advised Trustees that all road work prior to the chip & seal has been completed, summer help is keeping up with mowing, and roads and signs were checked and some signs were replaced. Ritterbeck made a **motion** to purchase a qwikchute and flex forks for a mower, seconded by Haueter. Ritterbeck:yes; Ackerman:yes; Haueter:yes. **Motion** passed. Trustees will have a Records Retention Commission Meeting on Thursday, July 14 at 6:50 p.m. Mann advised trustees she received reimbursement check for cement work, new phones have been installed and FEMA report was submitted.
