Regular Meeting

September 8, 2022

The Trustees of Lawrence Township met in regular session at 7:00PM. in the Charles E. Lundenberger Memorial Meeting Room. The meeting was called to order by Chairman Ritterbeck. Trustee Ritterbeck and Haueter were present.

RESOLUTION

Ritterbeck made a **motion** to approve **Resolution 31-22** Resolution Accepting the Amounts and Rates as Determined by the Budget Commission and Authorizing the Necessary Tax Levies and Certify them to the County Auditor, seconded by Haueter. Ritterbeck made a **motion** to approve **Resolution 32-22** Resolution Accepting Alternate Formula for Distribution of Local Government and Local Government Revenue Assistance Funds as proposed by the Tuscarawas County Budget Commission, seconded by Haueter. Trustees agreed for work session for ARP funding for 6:00 p.m. September 25, 2022. Ritterbeck thanked McNutt for working the scrap tire program Saturday, September 10. Haueter announced the Trustees are accepting applications for an additional full-time road worker. McNutt presented Trustees with a proposal from Martin L. Dreher, Inc. for repairs of catch basin and curbing in Holly Heights in the amount of \$2,750. Ritterbeck made a **motion** to approve the repairs, seconded by Haueter. Ritterbeck: yes; Haueter: yes. Motion passed. McNutt discussed tree trimming and additional trees need to be trimmed from roadways. Ritterbeck made a **motion** to approve up to \$5,000 for T. Rowley Tree Division LLC for additional tree trimming, seconded by Haueter. Ritterbeck:yes; Haueter:yes. Motion passed. McNutt advised paving will begin in 1-2 weeks, and maintenance work is being done on backhoe. Zoning Inspector Weekley spoke with developer Mike Durbin regarding detention basin and will contact him again next week; working on updating the zoning map; working on adjusting the driveway permit; and will reach out to Hess Mill residence again regarding the junk car. Ritterbeck thanked the Community Business Association for their donation of \$200 and a private resident for donating \$500 to the new Lawrence Township/Wilkshire Hills sign. Mann advised the Towpath Rotary Club is having a Health Check Event on October 22, 2022 at the Bolivar Army-Navy from 6:00am to 10:00am.

The Board then discussed Township affairs in general and a motion to adjourn was made and so ordered by the Chairman.
