Meeting was called to order at 7:08 p.m. by Chairman Glenn Myers.

Kline motioned, Kane seconded to add numbers 6. Family Day Care Home Type "A", 9. Churches, 10. Licensed Group Home for Handicapped Persons, 12. Recreational Facility/Use, Type B, 13. Granny Cottage, 14. Home Occupation, 15. Office (excluding medical), and 19. Temporary Storage/Pods on page 104 of WB, all approved.
Kline motioned, Scott 2<sup>nd</sup> to accept 303.3 H1 A & B on page 105 of WB, all approved.
