Minutes of Lawrence Township Trustees

Regular Meeting

September 11, 2025

The Trustees of Lawrence Township met in regular session at 7:00PM. in the Charles E. Lundenberger Memorial Meeting Room. The meeting was called to order by Chairman Trustee Haueter.

Minutes from the August 28, 2025 regular meeting were approved.

The above bills were approved by the Board and checks were written and Fiscal Officer presented August bank reconciliation.

PUBLIC SPEAKS

Kyle Quillen asked Trustees to close a portion of Wilkshire Blvd due to Sparks of Giving from 2pm to 11pm on September 13, 2025. He explained the events of the day and fireworks at night. Bolivar Fire Chief Lynch indicated there has been a significant increase in accidents on St. Rt. 212 and he is going to request O.D.O.T to do a traffic study. Bolivar Fireman Roger Bethel indicated they are having some issues with the fire truck regarding paint and rust issue and they believe they will not pass inspection and have not heard back from Atlantic Emergency Solutions and asking the township to step in to see if they can get the issues resolved. Justin Reidl discussed swimming pool issues with Army Core of Engineers and retaining wall issue at Hoffman.
